
PERSONAL DATA PROTECTION POLICY

of the online platform

Effective from March 2025

1. INTRODUCTION

The company under the name “Sea Circle Hellas M.I.K.E.”, with the distinctive title “SeaCircle”, based in Marousi, Athens, at 62 Kifisias Avenue, P.C. 151 25, hereinafter referred to as the “Company”, as data controller, informs you about the collection and processing of your personal data when using the online platform (hereinafter “Platform”).

Personal data is any information relating to an identified or identifiable natural person who uses the Platform.

The protection of your personal data is very important to our Company, and we take measures in this direction when you use the Platform. This Personal Data Protection Policy outlines the type of information we may collect when you use the Platform and how we use this information. When you voluntarily provide personal information, such as your name or email address, we treat this information with absolute confidentiality. Unless otherwise stated in this Policy, no personal information is rented, sold, publicly posted, or shared with other companies or organizations.

Please read this document carefully before using the Platform.

As stated in the Platform’s Terms of Use and the Cookies/Sessions Policy, the services provided through the Platform are directed to a specific audience, do not target children, and do not knowingly collect personal information from children under 15 years of age.

This Personal Data Protection Policy applies to all users of the Platform and governs the collection and use of your personal information by the Company (e.g., information that identifies a specific person such as full name or email address).

2. WHAT INFORMATION WE COLLECT FROM YOU

When you use the “Platform”, we collect data from you. Some of this data may be of a personal nature. This data may include:

- Contact details you enter, such as: Email, Last Name, First Name, WhatsApp Phone, Mobile Phone, Landline.
- Specializations and certificates required for registration in the Registry.
- IP address, Sessions.

- If you use a mobile device, we may also collect data identifying your device.

3. HOW WE COLLECT YOUR PERSONAL DATA

We collect your personal data directly from you. Specifically, you provide us with your personal data when you express interest in registering in our Registries via the “Platform”.

4. USE - DISCLOSURE OF PERSONAL DATA

We use your personal data to fulfill the requirements of our collaboration.

The personal data we collect through the “Platform” is not disclosed or transferred to third parties. Exceptions apply to those required by the contract of the project in which we cooperate.

5. STORAGE - PROTECTION OF PERSONAL DATA

Our data centers, where your personal data is stored, are located within the European Union.

6. RETENTION PERIOD OF PERSONAL DATA

The retention period of your personal data depends on the nature and type of our cooperation and the Registry in which you are registered.

After the end of our cooperation, your data is deleted.

Exceptions apply in cases where the retention of your personal data is required due to specific project requirements.

7. YOUR RIGHTS REGARDING THE PROCESSING OF PERSONAL DATA

You have the right to obtain information regarding your personal data that we have stored at any time, in accordance with applicable legislation and free of charge. We may request proof of your identity before we provide you with this data.

You have the right to:

- Request correction or update of your data, and the “Company” will proceed to correct it immediately.
- Request the deletion of your personal data.
- Request the cessation of processing by the “Company” of your personal data.
- Request the restriction of processing by the “Company” of your personal data.

If it is proven that a data breach of your personal information occurred by the “Company”, resulting in material or non-material damage, you have the right to file a complaint with the competent supervisory authority (Hellenic Data Protection Authority).
